**Ministry Purpose:** This position plays a significant role in achieving the Catholic mission of the clinic and, thus, has a ministry purpose.

## Qualifications:

- 1. Agrees with the center's statement of faith, mission statement, and code of Christian conduct.
- 2. Is dependable, stable, and capable of committing to this position's responsibilities and duties.
- 3. Expresses a desire to reach at-risk patients considering abortion.
- 4. Believes in the sanctity of all human life from the moment of conception through natural death.
- 5. Has a sincere, mature faith and can share the gospel.
- Holds a current registry and OB credential and is in good standing (and is licensed in states that require licenses)
- 7. Exhibits strong interpersonal, spiritual, and administrative skills, takes initiative, and is flexible.
- 8. It is highly recommended that the RDMS team member complete NIFLA's Institute in Limited Obstetric Ultrasound Course if they are the main ultrasound provider at the clinic or acting as the clinic manager. If the RDMS is only training the nurses (See RDMS Training Supervisor - job description) or is not the main ultrasound provider at the clinic, completing the PULSE webinar is highly recommended to understand the limited scope of the ultrasounds being performed
- 9. Clear a background check, drug screening, financial background check, and provide a letter of good church standing from pastor.

- 10. Upholds the center's policies and procedures.
- 11. Supports the Catholic mission of the center and encourages the spiritual growth of staff and clients.

- 13. Able to share the faith with patients and pray with them as appropriate.
